Equal Rights and Responsibilities: We hold the same rights and responsibilities as fully bonded members, including entitlement to summer replacement requests, access to club amenities, and the right to vote in general elections. However, we are not eligible to run for the board of directors until our bond is paid in full

Late Cancellation and Fee Implications:

-Deadline for Cancellation: If our bond/membership cancellation request is received after the due date of April 30, 2025, the following conditions will apply.

-Obligation to Pay Fees: The bond/membership fees for the current season will be due in full.

-Consequences of Non-Payment: If these fees remain unpaid, the Upper Moreland Swim Club reserves the right to:

- a. Deduct the unpaid fees from our Bond.
- b. Revoke our participation in the 3-Year to Bond program.
- c. Exercise its right to not refund any bond payments already applied to our account.

This is to ensure the club's ability to maintain its financial commitments and obligations, even in

instances of late cancellations.

Compliance with Club Standards: We acknowledge the responsibilities associated with our membership status and commit to full compliance with the club’s standards and policies.

Fee Non-Payment Consequences: In the event that these fees are not paid, the amount equivalent to your Bond will be deducted. This ensures that the club can maintain its financial commitments and obligations, even in the case of late cancellations.

3 Year to Bond Holders do have the same rights to amenities as fully bonded members. **If membership is cancelled prior to payment of the bond in full, those prior bond payments will be forfeited to the corporation.**

Late Payment Penalties:

April 30 Deadline: Members paying dues after April 30, 2025, will incur a penalty of \$50.00.

15-Day Window: An additional penalty may apply if payment is not received within fifteen (15) days after the due date, as per By-Law IV, Section 13.
