- Current Red Cross Lifeguard Certification Required (copies on file)
- Current CPR/ First Aid/AED Certifications Required (copies on file)

- Working papers from local school district (if under 18)
- Completion of Criminal Record Check and a Child Abuse History clearance; must be presented before Opening day.

- Current CPR/ First Aid/AED Certifications Required (copies on file)

### Physical Demands

- Ability to react to emergency situations with quick movements, strenuous activity, and, on occasion, assist or lift persons in distress of varying weights.
- Required to have strong swimming skills
- Required to remain alert to dangerous situations while sitting, standing or walking for various lengths of time outside during summer months (Memorial Day- Labor Day)

- Completion of Criminal Record Check and a Child Abuse History clearance; must be presented before opening day
- Knowledgeable of a variety of swimming techniques and skills

### Physical Demands

- Ability to react to emergency situations with quick movements, strenuous activity, and, on occasion, assist or lift persons in distress of varying weights.
- Required to remain alert to dangerous situations
- Required to have strong swimming skills
- Ability to physically assist program participants in the act of swimming for learning purposes

### Duties and Responsibilities

- Punctual, reliable and responsible
- Demonstrate patience, passion and enthusiasm
- Problem solving and quick decision making skills
- Communicate professionally and effectively program participants to ensure all water safety rules are adhered to
- Communicate professionally and effectively with Swim Lesson Coordinator and other Swim Lesson Instructors

- 17 years of age by the completion of the lifeguard certification and CPR and First Aid certification
- Working papers from local school district (if under 18)
- Completion of Criminal Record Check and a Child Abuse History clearance; must be presented before Opening day.

- Ability to react to emergency situations with quick movements, strenuous activity, and, on occasion, assist or lift persons in distress of varying weights.
- Required to remain alert to dangerous situations while sitting, standing or walking for various lengths of time outside during summer months (Memorial Day- Labor Day)
- Ability to operate, lift and control various pool equipment items such as vacuums, lanelines, etc.
- Ability to lift/carry up to 50 pounds with the help of a cart/wagon
